



### How to Vote




Use a dark colored pen to completely fill in the oval to the left of your choice.

To make a correction, draw a line through the entire incorrect choice. You then have the option of making another choice.

### Optional Write-in

To vote for a write-in candidate, fill in the oval next to the write-in line and print the name.

## Referendum Measure

### Referendum Measure No. 90

The legislature passed Engrossed Substitute Senate Bill 5395 concerning comprehensive sexual health education. This bill would require school districts to adopt or develop, consistent with state standards, comprehensive age-appropriate sexual health education, as defined, for all students, and excuse students if their parents request. Should this bill be:

## Advisory Votes

### Advisory Vote No. 32 Engrossed Substitute Senate Bill 5323

The legislature imposed, without a vote of the people, a retail sales tax on pass-through charges retail establishments collect for specified carryout bags, costing \$32,000,000 in its first ten years, for government spending. This tax increase should be:

### Advisory Vote No. 33 Substitute Senate Bill 5628

The legislature imposed, without a vote of the people, a tax on heavy equipment rentals to consumers by heavy equipment rental property dealers, costing \$103,000,000 in its first ten years, for government spending. This tax increase should be:

- Repealed  
 Maintained

### Advisory Vote No. 34 Engrossed Substitute Senate Bill 6492

The legislature increased, without a vote of the people, the business and occupation tax rate for certain businesses, while reducing certain surcharges, costing \$843,000,000 in its first ten years, for government spending. This tax increase should be:

- Repealed  
 Maintained

### Advisory Vote No.35 Engrossed Senate Bill 6690

The legislature increased, without a vote of the people, the business and occupation tax on manufacturers of commercial airplanes, including components or tooling, costing \$1,024,000,000 in its first ten years, for government spending. This tax increase should be:

- Repealed

## Proposed Constitutional Amendment

### Engrossed Senate Joint Resolution No. 8212

The legislature has proposed a constitutional amendment on investment of public funds. This amendment would allow public money held in a fund for long-term care services and supports to be invested by governments as authorized by state law, including investments in private stocks. Should this constitutional amendment be:

## Proposed Charter Amendments

### Proposed Amendment No. 1 Non-Partisan Prosecuting Attorney

The Clallam County Charter Review Commission proposes an amendment to the Clallam County Home Rule Charter, concerning the Office of the Prosecuting Attorney. This amendment would make the Office of Prosecuting Attorney a non-partisan office. Should this amendment be:

### Proposed Amendment No. 2 Clarifying Charter Section 4.10

The Clallam County Charter Review Commission proposes an amendment to the Clallam County Home Rule Charter, concerning the clarification of Article IV, Section 4.10. This amendment would insert the word "County" before the word Commissioners to clarify any ambiguity as to which Commissioners are being referenced. Should this amendment be:

### Proposed Amendment No. 3 Frequency of Charter Review Commission Elections

The Clallam County Charter Review Commission proposes an amendment to the Clallam County Home Rule Charter, concerning the frequency of Charter Review elections. This amendment would change the frequency of elections from 5 years to 8 years. Should this amendment be:

### Proposed Amendment No. 4 County Commissioners Elected Countywide

The Clallam County Charter Review Commission proposes an amendment to the Clallam County Home Rule Charter, concerning the election of County Commissioners. This amendment would change the system of electing County Commissioners to a system in which County Commissioners will be nominated by district and elected by the voters countywide. Should this amendment be:

### Proposed Amendment No. 5 Appointment of Director of Department of Community Development

The Clallam County Charter Review Commission proposes an amendment to the Clallam County Home Rule Charter concerning the appointment of the Director of the Department of Community Development. The amendment would remove the Director of the Department of Community Development from elected county officials, thus returning it to an appointed position. The amendment shall become effective at the end of the elected Director of the Department of Community Development's term. Should this amendment be:

### Proposed Amendment No. 6 Signatures Required for Petitions

The Clallam County Charter Review Commission proposes an amendment to the Clallam County Home Rule Charter, concerning the number of signatures required for an initiative petition to repeal the Charter. The amendment would change the number of signatures required to file an initiative petition for repeal of the Charter from 35% to 20% of the number of voters who voted for the office of governor in the last statewide election. Should this amendment be:

### Port Angeles School District No. 121 Proposition No. 1 Replacement Educational Programs and Operation Levy

The Board of Directors of Port Angeles School District No. 121 adopted Resolution No. 1920-15, concerning a proposition to finance educational programs and operation expenses. This proposition would authorize the District to levy the following excess taxes, in place of an expiring levy, upon all taxable property within the District, for support of the District's General Fund educational programs and operation expenses not funded by the State of Washington:
