Executive Summary:


The 2014 Draft Budget is hereby presented for discussion and modification prior to the final public hearings, on Dec 3rd and an adopted budget on December 10, 2013. After including all the changes approved during the BOCC/Department Head Budget Meetings, together with updated information on new grant and tax revenues and benefit expenditures, the General Fund revenues are higher (\$384,433) than in the Administrator's Recommended Budget, up to \$31,980,219. Expenditures also increased (by \$386,406) to \$32,368,543. Total use of General Fund reserves to balance the budget is \$388,324, leaving \$9,611,676 or \$493,249 more than the \$9,118,427 required by County Policy (\$7,500,000 restricted + 5.0% of General Fund Expenditures). Also included in this packet, for discussion purposes, is the 10 year Capital Facilities Plan, detailing projects and expected costs for REET I, REET II, Capital Projects and the Carlsborg Sewer Funds, together with the Road Department's 6 year TIP, and Draft Resolutions for the General Fund and Road Fund 1% Property Tax increases. Please review the attached budget schedule data, together with the 2014 Department Requests Over Base Budget sheet and feel free to ask me, Debi Cook, or any Department Head any questions that you might have.
