

Amending Clallam County Code Chapter 13.04, Clallam Bay/Seki Sewerage Rate Schedule,
to increase fees

BE IT ORDAINED BY THE BOARD OF CLALLAM COUNTY COMMISSIONERS:

Section 1. Section .030, Rate schedule, is amended to read as follows:

- (1) Commercial and Government
 - (a) From the first day of the month immediately following the effective date of the ordinance codified in this chapter through December 31, 2009~~17~~:
 - (i) \$~~47-53~~ basic
 - (ii) \$0.0~~67~~ per cubic foot over 700 cubic feet per month
 - (b) From January 1, 201~~08~~, through December 31, 201~~08~~:
 - (i) \$~~48-55~~ basic
 - (ii) \$0.0~~67~~ per cubic foot over 700 cubic feet per month
 - (c) From January 1, 201~~19~~:
 - (i) \$~~49-56.50~~ basic
 - (ii) \$0.0~~67~~ per cubic foot over 700 cubic feet per month
- (2) Dwelling Units
 - (a) From the first day of the month immediately following the effective date of the ordinance codified in this chapter through December 31, 2009~~17~~:
 - (i) \$~~42-47.50~~ basic
 - (ii) \$0.0~~67~~ per cubic foot over 700 cubic feet per month
 - (b) From January 1, 201~~08~~ through December 31, 201~~08~~:
 - (i) \$~~439~~ basic
 - (ii) \$0.0~~67~~ per cubic foot over 700 cubic feet per month
 - (c) From January 1, 201~~19~~:
 - (i) \$~~44-51~~ basic
 - (ii) \$0.0~~67~~ per cubic foot over 700 cubic feet per month

Section 2. Section .040, New connection assessment, is amended to read as follows:

Whenever any person or entity desires to connect to the existing Clallam Bay/Seki sewerage system, such person or entity is required to pay the following fees:

- (1) \$1,0~~500~~ connection to system
- (2) \$~~50-75~~ inspection
- (3) Standard Participation. For a property to receive sewerage service outside of the Clallam Bay/Seki sewage district boundaries a fee of \$~~23~~,000 will be assessed.

Section 3. Section .050, Repeal of prior fees, is amended to read as follows:




